





Sealed tenders are invited for providing facilities/infrastructure for skill test on computers like stenography test, typing test, computer proficiency test for various recruitment exams conducted by the BSSC. The Bihar Staff Selection Commission is mandated to make recruitment to non gazetted posts under the Government of Bihar.

02. Tender document is to be submitted in two parts comprising, Part-1 Technical Bid & Part-II: financial Bid. The Part-1 (Technical Bid) Should contain the EMD and statement showing compliance with the criteria /detailed technical specifications as per NIT. The Part-II (Financial Bid) Should contain the price offered. Both the parts should be properly marked and enclosed in separate sealed envelope for their proper identification. The envelope superscribed TECHNICAL BID AND FINANCIAL BID should again be sealed in a bigger envelope superscribing the tender No. and TENDER FOR PROVIDING FACILITES /INFRASTURCTURS FOR Skill Test" and name and address /Mobile No. of Tenderer. The part -1 (Technical Bid) will be opened in presence of the tenderers or their authorized representative on the date of tender opening and the part-II (Financial Bid) after evaluations of part-I on ground by the evaluation committee. The Part-II of only those tenders shall be opened who are found technical qualified to carry out the work, for which prior intimation will be given indicating the date and time of financial bid opening.

03. The basic requirements for conducting skill tests of various types for recruitment examinations of BSSC, Patna includes convenient accessibility to location by public transport, infrastructure (space, electric power, computers, printers, UPS, internet connectivity server and their respective backups), confidentiality & security in the premises, back end support technical & manual staff to help during skill test examinations.

04. **Eligibility Conditions: -**

- (a) The agency should have its own building, computer labs and premises. Priority will be given to such agencies. which have its own business & Premises.
- (b) The number of candidates in one shift should be at least 2000.
- (c) Arrangement of separate Entry and Exit for the candidates.
- (d) Room for waiting, documents, supervisors.
- (e) Rooms for manual document verification and online data entry with printers and internet connectivity.
- (f) Manpower for online data entry.

- (g) Sound proof Rooms for dictation required for stenographer skill tests only. Each room should have proper dictation taking facility/ infrastructure.
- (h) Two Computer Labs of 150 nodes or one lab of 300 with at least 2GB RAM each & LAN Printers with backup accessories for smooth & disturbance free conduct of skill tests.
- (i) Server with at least 4 GB RAM.
- (j) Internet connectivity with back-ups.
- (k) Power back-up with online UPS & Generator Sets.
- (l) Adequate manual & technical manpower support.
- (m) Drinking water and sanitation facilities.
- (n) Adequate security arrangements.
- (o) The bidder should be located and have their base in Patna.
- (p) The bidder should have minimum experience of two years in the related field of providing infrastructure / facility for conduct of skill tests on computers to reputed institutions /organizations.
- (q) The bidder should not be in the list of blacklisted/ debarred/ depaneled by any Government organization during last five years.
- (r) The Agency should be registered with Directorate of Service taxes.
- (s) Only such bidders will be considered for allotment of work that are having in their possession adequate infrastructure i.e. own hardware and experienced & qualified manpower.

5. **Terms & Conditions:**

- i) Successful bidder will be required to execute an agreement on non-judicial stamp paper of Rs. 1000/- [Rupees one Thousand only] and deposit Performance Security of Rs. 2,00,000/- [Rupees Two Lakh only] before issuing allotment letter which shall be refunded after completion of the contract.
- ii) Offer of rates will be submitted by the parties separately for the jobs.
- iii) The contract holder should also be able to provide manual & technical manpower support as & when required for smooth & disturbance free conduct of Skill Tests.
- iv) No person other than the authorized officials of the firm and/or the official of the office BSSC duly authorized by an order issued by the Secretary, BSSC will have any access to the premises of Skill Tests Centre. Such authorized officials will be responsible for guarding the secrecy & confidentiality of the materials etc. related with Skill Tests.

- v) The firm shall be required to provide the backups of all infrastructure/facilities in order to ensure smooth conduct of Skill Test.
- vi) Adequate security measures will be taken by the contract holder to fill any attempt of creating disturbance in smooth conduct of Skill Test. Unauthorized/forceful entry of a person, if any, shall be forthwith reversed.
- vii) It shall be the Endeavour of the contract holder to provide uninterrupted service of infrastructure/ facilities stated.
- viii) The BSSC reserves the right to accept or reject any or all the tenders without assigning any reasons.
- ix) Conditional Offer will not be accepted and validity of offer shall remain open for a period of six months from the date of opening of tenders.
- x) In the event of any tenderer withdrawing after accepting the contract without sufficient reasons acceptable to the competent authority or/and refuses to provide infrastructure for Skill Tests or delays the same unnecessarily, the performance security deposit will stand forfeited and the firm will be black listed. The decision of the BSSC will be final and binding on the tenderer.
- xi) The Regional Director shall have the authority to impose penalty to the tune of at least Rs 100/- per candidate per day, taking into consideration the delay and loss caused in the completion of work.

6. **Empanelment of Agencies: -**

- (i) The Commission will empanel two or more agencies in addition to the lowest bidder (L1) on their written consent to work at the rates of lowest bidder.
- (ii) All empanelled agencies shall have to enter into a contract with the Commission separately and individually by signing of the agreement and this will be effective from the date of signing of the agreement. All empanelled firms shall have to submit a performance security of Rs. 2,00,000/- (Two Lakh) only at the entering into agreement/contract. All other terms & conditions will remain same for all empanelled agencies.
- (iii) The BSSC reserves the right to assign the full or part of the work to one or more agency as per requirement.

7. **Period of Contract: -**

The empanelment of agencies will be for a period of one year initially from the date of signing the agreement/contract extendable for further two years (One year at a time) on satisfactory performances.
